023 unprivileged children received free English Preschool education inclusive of all requisites.

002 unprivileged students received complete sponsorship of formal academic English Education.





(Free English Preschool Education)



"SMILING STARS ENGLISH PRESCHOOL"

Preschool education is a non-formal education as per State Education Deptt, Maharashtra, it is universally a necessity for enrollments in formal education.

Smiling Stars English Preschool is a project of Helping Hand Foundation which enrolls unprivileged children at the age of 3 from the families of migrant "footloose" rural daily wagers who are unaffordable to provide any education to their children, this preschool delivers standard quality mainstream preschool education and holistic development of a child including provisions of books, stationary, bags, uniforms, nutritious products, celebration of all major events & festivals, Summative assessments, digital learning all free of any cost. This year we catered to 023 students who were shortlisted from a waiting list of 070.







(Formal Education Sponsorship)

During the year o2 children received complete sponsorship of their formal academic education in English. These children are ex-students of Smiling Stars English Preschool, due to unaffordablity of formal English Education, they are susceptible to drop off education, hence it is just and necessary to get them mainstreamed in formal schools through sponsorship of their academic education, the children are regular in their schools and happy to be at par with mainstream students of the locality.



(Remedial / Holistic)



"SUMMER CAMP, 2k19"

Summer Camps offers holistic opportunities to children for their growth while socializing & learning new skills.

This year, the summer camp was organized from 22.04.2019 to 27.04.2019 for 50 unprivileged kids, which is new to them as they have never heard of it before, it was overwhelming to see them eager to learn new things, socialize, make friends, active participation in activities and games, team work developing habits of sharing and caring under limited resources. (SUCCESS STORY OF ALFIA)



FROM AN URCHIN TO A STUDENT OF A FORMAL ENGLISH SCHOOL

Urchin Hood: Age 3.0 Years

Live was not easy for Alfia and her migrant family of 13, her father worked as a irregular daily-wage laborer at the local village grocery store, having a meager income, it was toughest to feed 13 mouths, pay the slum rent, electricity bills and educate the siblings of Alfia, being the youngest Alfia moved around the slum area hungry and playing all day in dirty surroundings, among the garbage pile-ups and human /animal faeces.

Introducing Preschooling:

We introduced the importance of English education especially for a girl child to her family who at first were reluctant to enroll her in our preschool citing religious beliefs, unaffordablity, "being a girl" stigma etc... but were overwhelmed to learn that Alfia would be a uniformed preschool student and receive the best English education along with nutritious products, celebration of major events, games, toys, sports etc...

True Potential:

Alfia studied in our preschool for 3 years (Nursery to SR.KG), following which she was enrolled in Formal English school and is currently studying in Class 3, at school she is a bright and sincere student, Yes! We continue to sponsor her complete education expenses at the formal school, thus ensuring she doesn't drop-out.

PUBLIC HEALTH

"Preventive Health Screenings, Nutrition & Awareness"

IMPACT DURING THE YEAR

Cumulatively **204 direct** beneficiaries received free assistances from Medical First aid Boxes, First aid Stations, Medical Screenings Camps and provision of medical aid.





(Preventive Medical Health Screening Camps)



Preventive Health Screenings matter because they allow you to be proactive with your health

The main objective of the camp was to medically screen the vital parameters of every beneficiary with appropriate consultations based on prognosis / diagnosis purely on humanitarian grounds. As the beneficiaries often lacked access to basic medical health screenings and are ignorant of the underlying health issues which might be damaging their physics, work performance and social outreach, thus identifying and highlighting the risk factors that can be managed in order to prevent further medical complications, these camps are free of cost and was organized on 26th Jan, 2019 at Uttan Coastal Police Station, Village Uttan.







(Medical First Aid Stations)



A temporary facility to provide medical first aid during major events

The main objective of the stations are to provide immediate medical first aid assistances to casualties participating in major events free of cost and was set up at Our Lady of Vailankanni Shrine, Bhatebunder, Uttan, Mira Bhayander on 22nd May, 2019 and from 29th August, to 9th September, 2019 which was operational from 4.45 Hrs to 11.00 Hrs and 16.30 Hrs to 22.00 Hrs during the said tenure and catered to casualties.







(Medical First Aid Boxes)



Medical First aid boxes are placed at police check points on rural arterial roads, entry/exit points to rural areas and the fire department in rural areas, for emergency assistances in case of fatal road accidents, medical emergencies in absence of any medical facility in the vicinity, the said boxes are maintained by us and replenished with new stock of contents every quarter. This has helped many casualties reach hospitals in stable condition.







(Medical First Aid Sessions)

These Sessions equips the learner with the knowledge, practical skills and understanding required to provide appropriate first aid treatment to casualties. This year we delivered a session to high school students of Amcha Ghar English School, Village Uttan, Bhayander free of cost.







(Provisions of Nutritious Food Product "Postik Aahaar")



Malnutrition slows a child's development making them vulnerable to a number of illnesses, most of our beneficiaries who are from the rural migrant "footloose" daily wager families do not have any breakfast, at times even lunch, due to unaffordablity, hence we try to supplement their meals through provisions of nutritious food products & dates from time to time. The students of our preschool are provided good quality Iranian Dates regularly.







(Medical Aid to Elders)



A homeless and unemployed elder being an amputee (Right Leg) and suffering from Cardiac Anomalies, Epilepsy and Diabetes is accessed to his monthly medicines and hunger relief products through us.

The unprivileged members of rural migrant daily wage families do not afford good clothing often, they gladly receive preowned clothing donated by like-minded donors, some clothing also aids them in procuring most used house hold items, thus saving their hard earned money.

(Free Distribution of Academic Education Requisites)



The unprivileged children of rural migrant daily wage families struggle to procure school books and stationary every year, they look forward to us every year and receive free set of good quality notebooks and stationary which helps them focus on education and drop off.


